AIMS

The aims of the Bensington Society are:

- To encourage a spirit of community.
- To preserve, protect, develop and improve features of historic or public interest.
- To promote, support and publish research into the history of Benson and its satellite villages.
- To stimulate public interest in matters of local concern, promoting high standards of planning and architecture, and protecting and enhancing Benson's physical character and rural environment.
- To work with other groups, organisations and individuals to improve facilities
 offered to residents for recreation and leisure activities.

1. Chairman's Annual Review

Some thirteen months ago, because there was no one prepared to volunteer as Chairman, I was asked to take on the task, having been Chairman for some years in the past. I agreed with some trepidation. In the event I have been supported by an outstanding committee and the task proved much easier than expected. In particular, John Tchighianoff, Membership Secretary, agreed to remain for a final year to help me out, Fenella Galpin produced an outstanding list of speakers, and Ken Blake and Ann Wright who have settled into their roles as Treasurer and Secretary respectively. I am delighted that John Tchighianoff's role as Membership Secretary will now be filled by David Rhys-Davies. I have been an exceptionally lucky Chairman!

A highlight of the year was the recognition of Freydis Sharland's life and work in the awarding of an Oxfordshire Blue Plaque, unveiled at a ceremony at the family home in Brook Street on 18 May. Freydis was a key figure and previous President of the Bensington Society, and it was fitting that we sponsored and hosted a reception in the Canons' Room at St Helen's Church following the ceremony.

Membership of the Society has remained high and was 174 at the end of 2024, some memberships lapsed, others have taken their place. We note with sadness the deaths in 2024 of long-standing members of the Society – Rodney Davis, Jocelyn Dalton and Clive Bosley.

The financial situation is very strong and the Treasurer's report following this reflects the situation.

Brief reports on different areas of the Society's life follow this review, including the report of the History Group. Again, it is in a strong position and one in which we can all take pride.

Nevertheless, I am concerned about two aspects of our current activities.

- The first is the tendency to become merely a supper club, relying on a good speaker followed by a good meal. When I was formerly Chairman, the Society had been much more concerned with village matters. Since then, Benson has doubled in size without any specific involvement from the Society.
- Secondly, a feature of our Summer activities was a series of external visits. It is to be regretted that no one was prepared to volunteer to arrange them, but I am encouraged that this is currently under consideration again.

Reports from the Committee.

History Group Report. History Group, which is a sub-group of the Society, has been busy throughout the year with projects and work in the archive store. Thanks to the Parish Council, just over a year ago, a home was found in the new community hall to store village archives and progress has been made in cataloguing a large number of items with scanning where possible. Work is ongoing to identify and sort through a sizable amount of material. History Group members are continuing to compile a Buildings

Database and research subjects such as farming in the 1700/1800s, as well as assisting at the Library's Family History Clinic and at the RAF Benson Heritage Centre. The Heritage Open Day at St Helen's Church in September was an opportunity to display some of the archive material and the maps, models and photographs of old Benson attracted considerable interest. Enquiries are regularly received via the website www.bensingtonhistory.org where more information and contact details are available.

Friday meetings. Over the year our membership has grown because we have interesting, informative and entertaining speakers but also because we all appreciate the chance to eat and drink together with friends in a convivial atmosphere. We are grateful to Barbara Verdon for running the raffle, the members who have contributed salads, Benson Butchers for providing ham, David and Liz McGill for organising and reimbursing the salad-givers, David McGill for bringing in, amongst other things, bread and cheese, Sue Cooper and her husband for running the bar, the washing up team and last but not least Anna Pieron for bringing it all together. Long may this continue in 2025! Despite rising costs for both food and drinks, the Friday evenings have run at a small surplus for the year and the Committee has agreed not to increase the current £5 per head for supper.

Planning issues. Members are encouraged to take part in planning and other consultations that affect the village, such as the changes in bus routes and applications for further developments. Updates on the repair of the weir and progress on the relief road have also been provided.

Governance

The Bensington Society is governed by its Constitution, supplemented by the Rule Book; both of these documents are available on the Society's website and in Benson Public Library (in the Society's folder). The constitution is based on the Charity Commission model constitution for small charities and was adopted in 2015, with amendments in 2023 and 2024. As a small charity, the Bensington Society is registered with HMRC, enabling it to reclaim Gift Aid, but is not registered with the Charity Commission. The charity is managed by a Committee of Trustees, as per clause 10 of the constitution, who act as an Executive Committee, elected annually at the AGM and consisting of the Officers (Chairperson, Secretary, Treasurer and Membership Secretary) and not less than three other members.

In meeting their responsibilities, the Committee have received reports from Pete Eldridge on his work in risk assessment and management and health and safety matters. A review of cyber security and GDPR will be undertaken in 2025.

2. Treasurer's Financial Statement.

It can once again be reported that the Society's assets have grown during the year, by £1130 in 2024. The running surplus from our monthly meetings amounted to £386.89. This is based on takings from Bar and Supper sales but does not take account of any movements into or out of stock. Also excluded from these figures is the receipts from the monthly raffle, the surplus of which is usually donated to charity or local good causes. At the AGM in January 2024, it was agreed that these would be The Air Ambulance, The Millstream Centre and Maggie's Oxford.

Towards the end of the year a card machine was introduced for payments at the monthly meetings. Apart from some confusion at one meeting it seems to have been successful, taking payments for Suppers, the bar, visitors and membership.

There have been several non-recurrent items of expenditure for the Society during the year. Some significant donations were made such as the contribution towards the cost of the Blue Plaque for Freydis Sharland. Significant sums were expended on the replacement of the audio-visual equipment used for the monthly meetings.

Balance in the Lloyds Bank account on 24th December 2024 was £6102.82. This excludes membership fees of £168.00 paid direct for the 2025 year as at 29th December.

£26047.79 is held on deposit at the Coventry Building Society which saw interest received of £1416.31. Cash-in-hand totals £466.93 which represents floats for the monthly meetings plus odd cash of £36.93. Additional floats are held by the Bar (£60) and Raffle (£40).
